Meeting Minutes:

Opening Updates from Kevin:

-2018 Outdoor State Championship bid cycle is complete – Greeley JOAD was awarded the 2018 Colorado State Outdoor Championships – They will host the event in Ft. Lupton on September 15th, 2018

-Once sanctioned, USA Archery will market event to all members statewide

-In case of severe weather, September 16th is a backup date

-2019 Indoor State Championships bid requests will be sent out at the end of August – Any and all clubs are encouraged to submit bids for this event to create a productive competitive bid process

-Club Leaders were reminded that there is increasing demand for Adult programs in the state – encouraged to develop more shooting opportunities for Adult USA Archery members

-USA Archery is always looking for opportunities to spread information about USA Archery programs to new audiences. Members who become aware of events where USA Archery may be able to have a booth are encouraged to send those ideas to Kevin

-USA Archery Member website has been running smoothly for the past 6 months or so

-Free club websites previously provided by archeryevents.com will be discontinued

2018-2019 Colorado Indoor Buckle Series Hosts

The following tournament schedule/hosts was created through our normal process of working through the list of clubs in the order selected through drawing in 2016.

NOTE: The USA Archery Indoor State Championship will be separated from the series and awarded through the bid process.

Selected Dates and Tournament Hosts:

October 13th and 14th 2018 – Youth Archery Academy
November 17th and 18th 2018 – Rocky Mountain Hot Shots
December 8th and 9th – Archery School of the Rockies
January 12th – Aslan (Date pending verification with venue)
February date tbd – 5280 Archers
March date tbd – Hitmen

Other Notes:

Leo and Paul have been developing a website to host information on “everything archery” in the state of Colorado. It currently has a calendar of events among other content and can be found at archeryincolorado.com

Creation of Rules/Regulations for Colorado Buckle Series Events:

Majority of the representatives reiterated their support for a documented set of standards to be applied to the Colorado buckle series tournaments.

Majority of the representatives indicated a belief that they should be clear and simple, contain some sort of process for enforcement, some sort of process for amendment, and be posted in a public place.

Through vote, it was decided that a final, ratified copy of the document would be published on Coloradojoad.org.

After much discussion, it was decided, through vote, that the creation of a final document will be completed through the following method:

1. The Colorado Advisory committee consisting of Leo C, Jim F, Kristen H, Karin B, and Frank B will create a document of rules and standards to be followed by hosts of the buckle series events
 - a. They will openly accept input from any members who wish to reach out to them in ideas
 - b. They will use Kevin’s rough draft document as a starting point where they see fit
 - c. They will have a completed document sent to Kevin by August 31st.
2. On September 1st, Kevin will distribute the document to all clubs for review and also create and distribute an electronic voting mechanism(likely surveymonkey) for each club to submit ONE vote of either Yes or No
 - a. The voting process will include a limited space for comment in the case of clubs voting “NO”
3. IF more than half of the clubs vote YES to the document will be considered “ratified” and all clubs hosting events in the indoor buckle series will be agreeing to meet the stated standards

4. IF NO votes are received by Half of the clubs or more, the feedback will be given to the Colorado Advisory Board to make updates and resubmit an amended document for another vote. Date expectations would be:
 - a. September 1st, Survey goes out
 - b. September 5th, votes are tallied
 - c. September 12th, new document and vote is distributed
 - d. September 15th, Second votes are tallied – If the second version fails to be ratified, the process will continue on this timeline until a ratified document prevails.

Initial discussions from Leo regarding rules:

- Majority in the room agreed that a point system should be used to determine buckle winner
- Majority in the room agreed that buckle money should be expected from hosts at the beginning of the season
- Majority indicated that they are happy with email communication but some indicated that email debate does not work
- Majority in the room agreed that the guidelines should include how to handle target changes
